

Set Up & Access Requirements

Set Up

A **space of 6 x 3 metres** is required for us to set up. The reason we need the space is because we provide our own marquee which we need to erect. The marquee is there to protect us from the sun and rain. For evening events we also hang lights off our marquee, so we will **need access to power**.

It's okay if you don't have 6 x 3 metres of space, as our set up is very flexible and can be designed in different ways to suit the surroundings. However, this means we cannot erect the marquee; therefore, it is your obligation to provide us with shelter. For evening events we will still provide lights, however they need to be hung up somehow. If you don't have any place for us to hang our lights, then you will need to provide us with some form of light.

A **flat solid surface** is recommended for us to set up on. Please ensure it is safe for us to set up on.

Our **ovens** shall only be used in an above ground open-air situation with natural ventilation, without stagnant areas, where gas leakage and products of combustion are rapidly dispersed by wind and natural convection.

The following figures are diagrammatic representations of outdoor areas. Rectangular areas have been used in these figures – the same principles apply to any other shaped area.

Any enclosure in which the ovens are used shall comply with the following:


An enclosure with walls on all sides, but at least one permanent opening at ground level and no overhead cover (see Example 1).

Within a partial enclosure that includes an overhead cover and no more than two walls (see Example 2 & 3).


Within a partial enclosure that includes an overhead cover and more than two walls, the following will apply:

At least 25% of the total wall area is completely open, and at least 30% of the remaining wall area is open and unrestricted (see Example 4 & 5).


In the case of balconies, at least 20% of the total wall area shall be and remain open and unrestricted.




Outdoor Area - Example 1




Outdoor Area - Example 2

Access to the Set Up Area

Our equipment is portable; we only require a flat and solid access route with a width clearance of 70cm. If the access route to the set up area have any of the below difficulties, then you will need to choose a different set up location

- Routes with steps/stairs
- Width clearance of less than 70cm
- Uneven surface (I.e. pebbles)

Alternatives for set up locations may be at the front of the house, in the garage with the garage door open, outside the office, at the loading dock, in the car park etc.

Parking

We require parking spots for two vehicles; one car and one trailer. Please ensure these two spots are consecutive and available upon our arrival. If the event is held at home, then driveway access or direct street parking is required. If the event is elsewhere and parking incurs costs, the costs must be reimbursed by the client.

With larger events, we may need to request more car spots as we will be bringing extra trailers and cars.

Extreme Weather Conditions

In the circumstance of extreme weather, our marquee will not be erected due to safety regulations. You will then be responsible for providing appropriate cover to set up under. Notice may be provided, however if on the day we believe it is dangerous for us to put up the marquee, then you will need to provide us with covered space.

Please note that in the case of unfavourable weather, we do not provide discounts if the event is cut short.
